- 5. The Bank has got right to cancel/postpone the Sale without assigning any reason whatsoever.

The successful bidder should pay 25% of the bid amount (less EMD) immediately on sale being reckoned down in his favour and the balance 75% amount within 15 days of the sale being confirmed in his favour failing which the entire amount paid by the bidder shall be forfeited by the Bank, without any notice and the sale will be cancelled and the property will be brought to sale again
