## KNOWLEDGE CORNER



### FATCA/ CRS

The Foreign Account Tax Compliance Act (FATCA) is a United States federal law that requires United States persons, including US persons who live outside the United States, to report their financial accounts held outside of the United States, and requires foreign financial institutions to report to the Internal Revenue Service (IRS) about their U.S. clients. Government of India (GOI) has signed a Model 1 Inter-Governmental Agreement (IGA) with US on July 9, 2015 which necessitates financial institutions in India to comply with FATCA.

CRS is known as Common Reporting Standards. It is an information standard for the automatic exchange of information (AEOI), developed in the context of the Organisation for Economic Co-operation and Development (OECD). The Government of India has also joined the Multilateral Competent Authority Agreement (MCAA) on June 3, 2015 and financial institutions in India to comply with CRS.

While both legislations were introduced to combat tax evasion, CRS has a more considerable breadth of design. It covers several countries except the US. Reporting of all financial accounts is mandatory under the CRS, while it is not compulsory for FATCA. FATCA concerns only people living in the USA and has a limit that exempts US taxpayers with an aggregate value of foreign financial assets less than \$50,000. CRS does not have any such exemptions.

An IGA is a bilateral agreement between a country's government and the US government that facilitates compliance with FATCA. The model agreements enable Financial Institutions in the designated jurisdictions to comply with FATCA, especially where privacy laws exist.

Government of India (GOI) has signed a Model 1 Inter-Governmental Agreement (IGA) with US on July 9, 2015. The IGA provides that the Indian Financial Institutions will provide the necessary information to Indian tax authority i.e. Central Board of Direct Taxes (CBDT), which will then be transmitted to USA automatically in case of FATCA. The Government of India has also joined the Multilateral Competent Authority Agreement (MCAA) on June 3, 2015, for exchanging information with respective tax authorities from partner jurisdictions which are signatories to MCAA. To enable this, CBDT has issued a notification to all financial institutions in India to comply with the CRS and FATCA regulations.

FATCA legislation will affect both individual and non-individual customers who are treated as 'U.S. persons' for U.S. tax purposes. The FATCA legislation will also affect certain types of entities with beneficial owners/ controlling persons from U.S.

With respect to CRS, the coverage would extend to account holders/ beneficial owners or controlling persons of entities, being tax residents of any of the signatory countries

The information reported will depend on the classification of the customer under FATCA and CRS. Account holders will be expected to provide details such as Country of Tax residence, Tax Identification Number from such country, Country of Birth, Country of Citizenship, etc.
