igration, particularly from developing countries, has been a common phenomenon for years. People migrate when they find career or business opportunities, a better quality of life, or more lucrative opportunities in another country. Reverse migration is when these migrants return to their country of origin after a stint in a foreign country.

The need for reverse migration in India

The migration of humans from a country amounts to a loss of human capital. India is estimated to be third among countries with the maximum number of highly skilled individuals living overseas. The Indian government has been making a concerted effort to stop the brain drain from India and to trigger reverse migration to the country. Speaking during the interactive meet on 'Economy and the Vision for Amrit Kaal-2047' in April 2024, Finance Minister Ms. Nirmala Sitharaman pointed out that "Reverse migration has started in India, a lot of people who have a global footprint, are finding businesses, professions and careers to be built in India. Ideally, India should be a country worth our grandchildren to stay and live and lead their lives and contribute to the country rather than leading to better opportunities, job satisfaction, and career enhancement in other countries. "

Government schemes aiding reverse migration

Here are a few examples of the Indian government initiatives to gain interest among overseas Indians:

- Through initiatives like the Invest India campaign, India offers a one-stop solution to non-residents to do business in India.
- India facilitated Lifelong Visa-free Travel to overseas citizens of India.

- There are tax benefits in place for non-residents willing to invest in India, like the Foreign Currency Non-Resident FD and the Non-Resident External FD Accounts.
- The Ministry of External Affairs runs scholarship programmes for diaspora children in selected fields

These efforts increase the economic and social engagements of non-resident Indians with India, paving the way for international reverse migration. Reverse migration can also be a domestic social phenomenon, as seen during the COVID-19 pandemic.

Drivers of reverse migration

It can be rather puzzling to see migrants return to the places they originally left in search of greener pastures. However, various influential factors drive a reverse migration trend in society.

Economic factors: Economic downturn in the host region can influence migrants to return to their native place. If the economy takes a hit, there may be fewer job demands, rising cost of living, job loss, etc.

Political factors: Changes in government policies may make life difficult for migrants. If a country starts preferring natives for jobs over migrants or imposing xenophobic laws, it could trigger reverse migration.

Personal factors: Reverse migration can also be a personal choice for the migrant. The longing to return to the roots, familial ties, and culture shock in the host region are personal reasons that can influence a decision to reverse migration.

Homeland development: The economic and infrastructural development in the migrant's native place may inspire a reverse migration. The migrant can carry out business or profession closer to home.

Challenges of a reverse migration decision

A migrant and the family must consider several factors while deciding to embark on a reverse migration. This includes considerations like -

Adjusting to old life: A migrant gets used to a certain lifestyle while living in a foreign land. A sudden switch to the native place, particularly after a prolonged absence, can disorient the migrant and their family. Reverse culture shock is as real a challenge as culture shock.

Financial adjustments: A reverse migration changes the cost of living and income levels. An unavoidable reverse migration may also land the migrant in an inferior financial position. The migrants may have to accordingly adjust their lifestyle and spending habits.

Career compromises: A migrant may have to step down in his/her career to get closer to home. It is not uncommon to see migrants settling for a change in work profile or settling for lower pay while migrating reversely.



The United Arab Emirates' (UAE) economy grew by 3.6 percent in 2023, the Gulf state's central bank said in its annual report on Thursday. It projected overall output growth to rebound to 3.9 percent in 2024 on the back of a recovery in various economic sectors.

The UAE's economy grew by 4.3 percent year on year in the fourth quarter, preliminary government data showed last month, with non-oil economic growth vastly outperforming overall GDP.
