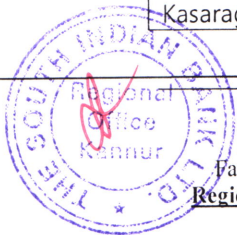


TENDER CUM AUCTION SALE NOTICE

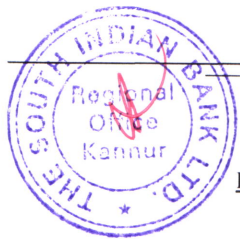

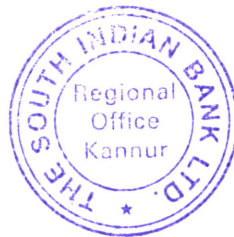
