- 8) The Sealed Tenders will be opened by the Authorised Officer on 19/01/2023 at 10.45 AM for item No.1 property, 11.15 AM for item No.2 property. Any tender received quoting a price below the Reserve Price will be rejected outright.
- 9) After opening the tenders, the Tenderers who are present may be given an opportunity at the discretion of the Authorised Officer to have inter se bidding among themselves to enhance their offer price.
