- 6) The Bank will be Shortlisting the Tenderer/s after evaluating the Tenders. Unsuccessful tenders EMD (as DD) shall be returned forthwith.
- 7) The successful tenderer should be directed to remit the balance Sale consideration in full (Less EMD) within 7 days. However, in desirable cases the time may be extended at the sole discretion of the Bank. The balance amounts (Less EMD) payable regarding the Sale shall be paid by way of RTGS/DD drawn in favour of "The South Indian Bank Ltd." payable at Thrissur.
- 8) On confirmation of the Sale after the receipt of entire sale consideration, the Sale deed will be executed in favour of the successful tenderer and the successful tenderer should pay the charges/ fees payable for registration of Sale Deed such as registration Fees, Stamp Duty etc., as applicable as per law.
