- 1) The secured asset will be sold by e-auction through Bank's approved service provider i.e. M/s.4 Closure who are assisting the Authorised Officer in conducting the online auction.

- 3) The intending purchaser shall submit duly filled in bid form in original (format available with Authorised officer and in website <https://bankauctions.in>) along with self-attested copies of Proof of identification/Address proof (KYC) to the Authorised officer and should carry the original for verification.
